- 5- **PURCHASES ON HIGHER RATES ON DEBITABLE BASIS IN CASE OF DELAY:** If the supply is delayed due to any reason in respect to the given schedule as per P.O., UPSBC may procure Prestressing items from any firm in the market on the rates available to avoid loss to work. The extra cost of such purchase shall be recovered from Earnest Money of the supplier.
- 6- **EARNEST MONEY:** A sum of Rs 5.00 Lac (Rupees Five Lac Only) for Tube Anchorages & CRCA B.M. Sheathing must be deposited as earnest money along with the tender in the form of: "F.D.R. pledged in favour of U.P. State Bridge Corporation Ltd. payable at Lucknow". Project Manager of BCUs (Consignees) situated in U.P. according to their requirements. 100% advance payment FOR destination (which includes basic price per ton, 100% taxes, such as IGST/GST, loading and freight charges, shall be made by the consignee.
- 8- **SPECIFICATION:**
 - (i) **For B.M. Sheathing:** The goods offered must confirm to the provisions as per IRC Code IRC-18-2000 & IRC: 112-2011 as per latest Revision.
 - (ii) **For Tube Anchorages:** The goods offered must confirm to the provisions as per latest relevant BS and FIP Code. 19T15, 19T13, 12T15 & 12T13 Tube Anchorages must confirm to the provisions as per BS4447:1973 & IRC:112-2011 Code
 - (iii) **Manufactures name/Trademark etc. must be stated in the offer. Complete technical literature/catalogue/drawings should be attached with offer failing which the same may be ignored.**
- 9- **TESTING:** The firm will have to provide test certificate as per latest relevant BS and FIP Code for Tube Anchorages & Sheathing the Corporation may also carry out third party test in presence of firm's representative. In case any nonconformity is observed all defective material shall be replaced immediately by the firm at its own cost.
- 10- **QUANTITY:** Quantity mentioned in the N.I.T. is approximate which can vary on either side. Supplier should be prepared to accept orders for reduced / increased quantities of Prestressing items without any extra charges and supply of prestressing items accordingly up to the validity of Rate Contract failing which security deposit shall be forfeited. No claim on this account for the change in quantity will be entertained.
- 11- **VALIDITY:** Validity of the tender should be 180 days. However, the rates given in tender should remain firm up to the validity of Rate Contract.
