14. Each bidder is required to furnish an affidavit online on a non-judicial stamp paper of Rs. 100/- giving all information on prescribed Performa required for evaluation of the bidding capacity of the bidder.
15. Bidder must submit information/document on prescribed Performa i.e. T4, T5, T6 in original with bid and photocopy of GST No., PAN, Labour Registration (if applicable).

According to the provisions of Government Order No. 3070/78-2-2018/42 II/2017 (22) Dt. 03.01.2018 after opening of the technical and financial bids, the bidder has to submit original documents personally in department/office. In the event of non submission of original documents by the bidders, the appropriate action will be taken in accordance with the provision of G.O.
