6. Bidder shall have to register on <http://etender.up.nic.in> for submitting the bid. This registration can be done free of cost any time. The bidders must have a Digital Signature Certificate issued by any Digital certificate certifying authority failing which submission of bid will not be possible.

In e-procurement system Bids must be submitted online on <http://etender.up.nic.in> on or before **14.01.2023 up to 05.00 P.M.** Bids can be submitted by the bidder as per the guidance provided on <http://etender.up.nic.in> up to the specified date and time. Technical bid shall be opened online on **16.01.2023 at 3.00 P.M.** at the **Office of the Dy. Project Manager, Shiv Vila, G.B.-2, Chandrashekhar Nagar, Ballia**. On Account of Government Holiday. The required process carried out next day at same time.
9. Bidder has to submit Tender documents all affidavits as per clause 4 of I.T.B, Tender Cost, Earnest Money, and all certificates in original in the Office of the **Dy. Project Manager, U.P State Bridge Corporation L.t.d Ballia** after opening of Technical & Financial Bid as per UP Government order No. 3070/78-2-2018-42 आई0टी0/2017 (22) आई0टी0 एवं इलैक्ट्रॉनिक्स अनुभाग-2 Dated 03-01-2018.

Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can be seen in the office of the Dy. Project Manager mentioned in column 7 of the table corresponding to the respective work between hours of 10.00 am and 05.00 pm on any working day between 07.01.2023 to 14.01.2023

12. Any bidder who is having criminal record is not allowed to participate in the bidding process.
13. Any bidder who is registered with the state Bar Council is not allowed to participate in the bidding process.
14. Each bidder is required to furnish an affidavit online on a non-judicial stamp paper of Rs. 100/- giving all information on prescribed Performa required for evaluation of the bidding capacity of the bidder.
15. Bidder must submit information/document on prescribed Performa i.e. T4, T5, T6 in original with bid and photocopy of GST No., PAN, Labour Registration (if applicable).
16. According to the provisions of Government Order No. 3070/78-2-2018/42 IT/2017 (22) Dt. 03.01.2018 after opening of the technical and financial bids, the bidder has to submit original documents personally in department/office. In the event of non submission of original documents by the bidders, the appropriate action will be taken in accordance with the provision of G.O.
17. Each bidder is required to furnish an affidavit on a non-judicial stamp paper of Rs. 100/- giving all information's on prescribed Performa required for evaluation of the bidding capacity of the bidder.
18. Department has right to reject any tender without showing any reason.
19. All work shall be carried out as per latest U.P. P.W.D. specification & also as per latest MORT&H / MORD specification and also as per latest circulars of Engineer in Chief UP PWD.
20. All rated are inclusive of Contractor's Profit, royalty, T&P and all taxes etc. except GST.
