**EXPRESSION OF INTEREST (EOI) FOR PROVIDING CONSULTANCY SERVICES FOR PROJECT MANAGEMENT FOR PHYSICAL PROGRESS THROUGH OPTIMUM USE OF RESOURCES, QUALITY CONTROL & SAFETY AUDIT IN PRAYAGRAJ ZONES OF U.P.STATE BRIDGE CORPORATION LTD., AS PER PRESENT WORKS IN PROGRESS**

**1. Availability of documents :**

The EOI document may be downloaded from the website of the UP State Bridge Corporation Ltd.'s Website: [www.bridgecorporationltd.com](http://www.bridgecorporationltd.com) The Consultancy firms are expected to examine all instructions, forms, terms, project requirement and other details in the EOI documents. Failure to furnish complete information as mentioned in the EOI documents or submission of a proposal not substantially responsive to the EOI documents in every respect will be at the firm's risk and may result in rejection of the proposal.

**Other general terms and conditions:**

1. The EOI should be submitted in sealed cover only. It is the responsibility of the vendors to see that their offers reach the above address by due date and time.
2. The person signing the Expression of Interest Documents should duly authenticate any errors or corrections in the EOI. Over writing should be avoided.
3. An authorized representative of the Vendor may remain present at the time of opening of the offers for Expression of Interest
4. This is an invitation for Expression of Interest and not a tender. No payment will be made to the vendor/responder of such Expression of Interest if their offer for Expression of Interest is considered acceptable.
5. As per existing provisions of IRC, all safety measures are to be accommodated in Planning, Design & Pre-construction Stage, during construction stage and post construction stage.

**3. The scope of services required in the project shall include :-**

1. To Supervise the ongoing works to ensure the proper execution as per approved drawings and specifications as indicated thereof.

2. To conduct and record various quality control tests as specified in relevant codes.
3. To advise the field staff/ execution agency if involved in execution the proper methodology and procedures for proper execution of work (documental evidences of such advice is necessary).
4. To prepare and submit daily report of execution/work being done to the authorities concerned.
5. To prepare a Check list with the help of competent authorities and submit a monitory report to all concerned.
6. Periodically Safety Audit should be conducted.
7. To prepare the detailed measurement of executed works as and when required.
8. To certify the various stages of construction, as required.
9. The details of various unit of Prayagraj Zone with value of works & Current Status are enclosed as **Annexure-I**
10. Details of Requirement of Technical Staff are attached herewith.

**4. Pre-Qualification Criteria :**

1. The firm should have one of its branches or offices located in Delhi, NOIDA, Greater NOIDA, Luck now or Ghaziabad.
2. In case of consortium, the lead partner should fulfill the given requirements.
3. Should have undertaken consultancy for at least 2 (Two) Similar projects.
4. Average of the consultancy fees received during the preceding five years as per balance sheet and auditor's certificate for each year should be at least Rs 100 Lakhs.
5. Should have undertaken at least two other consultancy projects during preceding 5 years for value of minimum Rs 25.00 lacs each.

**5. Offers shall be in Two parts :**

1. **Part-I** This shall be named as Technical EOI and shall comprise.
  - a. Processing fee of Rs. 5000.00 (Rupees Five thousand only) + 18%G.S.T. in the form of D.D.in favour of U.P.State Bridge Corporation Ltd., payable at Praptapgarh
  - b. Brief company profile.
  - c. List of projects done with year of completion and cost of the project.
  - d. List of project of similar magnitude along with year of completion and cost of the project and certificates from the clients.
  - e. List of Key personnel with their qualification & experience.
2. **Part-II-** This shall be named financial EOI and shall comprises fee to be quoted in terms of percentage of project cost bifurcating in different items of Scope of Work including service tax. Calculation of project cost shall be done as per standard practice/norms of UPSBC Ltd., after deducting contingency charges, Labour Cess & all those cost where Centage/ Contingency charges are not payable to the UPSBC by the Govt./Client and the cost of works which do not require designing services.

The cost quoted should be on percentage basis on Turnover value for each project.

Both the above sealed envelopes shall be kept in a larger envelop duly sealed and shall reach the Zonal Office of the Chief Project Manager (Prayagraj) U.P. State Bridge Corporation Ltd.,Prayagraj on or before specified date and time.

6. **EOI Evaluation**

(a) **Short listing** – Technical EOI shall be evaluated with respect to processing fee, qualification information's, experience and other information's furnished in Part-I and a list will be drawn up of responsive firms who are eligible for competition for providing consultancy services for project management for physical progress through optimum use of resources, quality control & safety audit in various unit of Prayagraj Zone of U.P. State Bridge Corporation Ltd., as per present works in progress

(b) Employer shall inform shortlisted firms the date, time and place for presentation of their proposal Drawings/ Designs which shall be evaluated by a high level committee formed by Employer.

The employer shall evaluate each technical proposal (using the evaluation committee, CEC), taking into account criteria as prescribed in the EOI: (a) the consultant's relevant experience for the assignment, (b) the quality of the methodology proposed, (c) the qualification of the key staff proposed and (d) capability for transfer of knowledge.

7. **Selection Criteria :-**

Each of the responsive technical proposal will be evaluated for the criteria prescribed in the EOI by awarding marks so as to make total maximum technical score as 100. The criteria and weightage to each criteria or sub-criteria would depend on the requirements of each case and may be fixed objectively. A model scheme of maximum marks is, however, proposed as under.


