

*Other general terms and conditions:*

1. The Proposal shall be submitted separately for each work.
2. *The EOI should be submitted in sealed cover only. It is the responsibility of the vendors to see that their offers reach the above address by due date and time.*
3. *The person signing the Expression of Interest Documents should duly authenticate any errors or corrections in the EOI. Over writing should be avoided.*
4. *An authorized representative of the Vendor may remain present at the time of opening of the offers for Expression of Interest*
5. *This is an invitation for Expression of Interest and not a tender. No payment will be made to the vendor/responder of such Expression of Interest if their offer for Expression of Interest is considered acceptable.*
6. *As per existing provisions of IRC, all safety measures are to be accommodated in Planning, Design & Pre-construction Stage, during construction stage and post construction stage.*

**3. The scope of services required in the project shall include :-**

1. Conducting detailed topographical survey by total station.
2. Detailed Sub soil investigation as per IRC/BIS Codes at required location throughout the length of Elevated road.
3. Conducting details traffic studies.
4. Preparation of Detailed Project Report (DPR).
5. Preparation of tentative General Arrangement Drawing (G.A.D.)
6. Providing detailed designing of Foundation, Sub-structure, Super-structure allied items, R.E. Walls, approaches roads, drainage and electrical furnishing & fittings for street light along with methodology for working, Considering Utility Services.
7. Preparation of detailed quantities, B.O.Q. detailed as per MORTH Specifications/Guideline's.
8. Getting vetted the design, drawing, B.O.Q. & estimate from I.I.T. & Bridge Corporation.
9. Attending the required meetings regarding design drawing and site visit for design related issues.
10. The time of submission of all the design drawings is 60 day's. However, the design consultants shall be associated with the project for the complete duration of completion of the project.
11. Necessary changes, if required in the design from time to time due to the site condition should be incorporated by the designer.

**4. Pre-Qualification Criteria :**

1. The firm should have one of its branches or offices located in Delhi, NOIDA, Greater NOIDA, Lucknow or Ghaziabad.
2. In case of consortium, the lead partner should fulfill the given requirements.
3. Should have undertaken consultancy for at least 2 (Two) Similar projects.
4. Average of the consultancy fees received during the preceding five years as per balance sheet and auditor's certificate for each year should be at least Rs 100 Lakhs.
5. Should have undertaken at least two other consultancy projects- during preceding 5 years for value of minimum Rs 25.00 lacs each

**5. Evaluation of the Quality:-**

The employer shall evaluate each technical proposal (using the evaluation committee, CEC), taking into account criteria as prescribed in the RFP: (a) the consultant's relevant experience for the assignment, (b) the quality of the methodology proposed, (c) the qualification of the key staff proposed and (d) capability for transfer of knowledge. Each of the responsive technical proposal will be evaluated for the criteria prescribed in the RFP by awarding marks so as to make total maximum technical score as 100. The criteria and weightage to each criteria or sub-criteria would depend on the requirements of each case and may be fixed objectively. A model scheme of maximum marks is, however, proposed as under.

**6. Selection Criteria:-**

Minimum 03 firms will be short listed for further consideration.





7. Fee : Maximum fee for the full design services as per clause 4 above shall be limited to approved percentage the construction cost of the project including all Taxes. Calculation of cost for the purpose of calculation of fee shall be as per norms of U.P.S.B.C.Ltd.

8. Offers shall be in Two parts :

1. **Part-I** This shall be named as Technical EOI and shall comprise.
  - a. Processing fee of Rs. 5000.00+GST in the form of D.D.in favour of U.P.State Bridge Corporation Ltd., payable at Varanasi.
  - b. Brief company profile.
  - c. List of projects done with year of completion and cost of the project.
  - d. List of project of similar magnitude along with year of completion and cost of the project and certificates from the clients.
  - e. A folder of Conceptual design of concerned project for which offer is being made.
  - f. List of Key personnel with their qualification & experience.
2. **Part-II-** This shall be named financial EOI and shall comprises fee to be quoted in terms of percentage of project cost bifurcating in different items of Scope of Work including service tax. Calculation of project cost shall be done as per standard practice/norms of UPSBC Ltd., after deducting contingency charges, Labour Cess & all those cost where Centage/ Contingency charges are not payable to the UPSBC by the Govt./Client and the cost of works which do not require designing services.


