

Bid must be submitted online only at the above e-tendering portal on or before 21/11/2019 upto 5:00 Hrs IST. Bids received online shall be opened on 22/11/2019 at 15:00 Hrs IST.
- Bid through any other mode shall not be entertained. However, Bid Security, document fee, Power of Attorney and joint bidding agreement shall be submitted physically by the Bidder on or before 21/11/2019 up to 5:00 Hrs IST in the offices specified in tender documents. Please note that the Ministry of Road Transport & Highways reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
3. Bids must be accompanied by Bid Security of the amount specified for the work in the above table drawn in favour of the "U.P. State Bridge Corporation Limited." Bid Security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 60 days beyond the validity of the bid.
4. The original DD / Bank Guarantee for bid security deposit and cost of tender documents should be deposited with the concerned Dy. Project Manager before the opening of the technical bid as given in the table above. The scanned copies of the same should be attached in Technical Bid as prescribed in the Bidding Document, failing which the bidder shall be disqualified.
