Both the sealed envelopes will be put in another envelope superscribed as "**TENDER FOR SHUTTERING/CENTRING AND STEEL SCRAP**" duly sealed and to be mailed or personally handed over so as to reach on or before the due date and time of receipt of tender. The envelope marked "**Earnest Money/Tender Cost**" will be opened first to ensure that the requisite earnest money/tender cost submitted in original and attested copy of prequalification bid document are as per requirement of this N.I.T.

2- FINANCIAL BID :

- (a) Rates should be quoted **ONLINE** in the format of “**Bill Of Quantity**” only.
- (b) “**Bill Of Quantity**” shall only be opened/entertained of the qualified firms, who have submitted E.M.D and Tender cost and prequalification bid as per tender satisfactorily.
- (c) If there is any change in Government levies/ taxes at the time of lifting, shall be applicable and born by tenderer .
- (d) Tenderer may participate in any / all zone / lot accordingly EMD must enclosed separately each zone/lot as mention in (Annexure –A)
- (e) EMD of successful tenderers will be treated as security deposit and will be release after successful competition of the work.
- (f) EMD of second and third highest bidder will be retained (hold by UPSBC) for two months because if first bidder did not lift the scrap in that case gives chance to second & third bidder for lifting the scrap.

3- Opening of Tender : The Tenders will be opened on the due date and time mentioned above by the competent Committee of U.P.S.B.C. Ltd in the presence of tenderers representatives who may like to be present at the time of opening. **Tender submitted/ received after due time will not be entertained.**

4- Earnest Money : The Earnest Money amounting (As per annexure - A) shall be submitted alongwith the tender by Demand Draft in favour of “ **U P State Bridge Corporation Ltd**” payable at **LUCKNOW**. EMD of the successful Tenderers will be treated as Security deposit (and retained by UPSBC) after issue of letter of acceptance. EMD of the Tenderers, whose tenders are not entertained/ accepted will be refunded without any interest thereof after finalization of tender and upon receiving letter of request from unsuccessful bidder to refund EMD.

5- Depositing Scrap Value- Tender will be finalized on basis of highest rate basis. After scrutiny of documents and approval from competent authority, letter of acceptance of rates will be issued to successful tenderer for depositing scrap value (calculated on basis of accepted rates of tender) including all taxes(GST, Income Tax etc.) Tenderer should deposit intimated amount in from of Demand Draft/RTGS in favour of “ **U P State Bridge Corporation Ltd**” payable at **LUCKNOW**. Within Ten days After receiving 100% payment as required, lifting order to lift shuttering/centering and steel scrap will be issued along with list of zone/unit where scrap had located. If scrap value is not received within schedule period, EMD of successful tenderer will be forfeited and next highest bidder (second & third) shall be asked for sending acceptance within one week to lift remaining steel scrap on rates of first highest bidder/ highest accepted rates of tender.

6- Performance of successful tenderer/Penalty clause-

- (a) If 50% of steel scrap was not lifted by successful tenderer(first highest bidder) within 1.5 month from the date of lifting order issued. penalty of 10% of scrap value (calculated on basis of accepted rates of tender) + Txes Additional of remaining unlifted quantity from lifting order issued , will be charged from successful tenderer and also lifting order shall be cancelled on basis of above poor performance and second/third highest bidder will be given chance to lift steel scrap on accepted rates of tender.
- (b) On cancellation of lifting order, second/third highest bidder shall be asked for sending acceptance within week to lift remaining steel scrap on rates of first highest bidder/ highest accepted rates of tender and on receiving acceptance lifting order shall be issued and second highest bidder has to give performance as detailed in sl no. (5) & (6a), otherwise penalty will be charged as detailed above.

7- Scrap Lifting Time: Within three months from the date of awarding the lifting order of shuttering/centering and steel scrap.
