

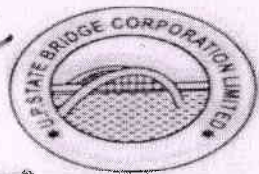

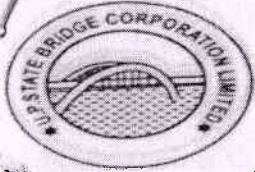

EXPRESSION OF INTEREST FOR THE EMPANELMENT OF  
CONSULTANTS FOR MAJOR AND SPECIAL TYPE OF BRIDGES

1. Expression of Interest for empanelment of consultants from reputed consultancy firms / organization with the following qualification/experience for preparation of Detailed Project Report of major bridges, flyover and Special type of Bridges such as curved bridges, cable stayed bridges, suspension bridges, extrados bridges etc.  
E.O.I. is required for empanelment of consultants, for design and pretender/ post tender consultancy for E.P.C. mode of works of major and special type of bridges.
  2. Essential Qualification
    - (i) The firm should be empanelled as consultant with ministry of Road Transport & Highways (MORTH) under CATEGORY-II.  
(For JV, any of the two partners should be empanelled)
    - (ii) Working Experience
      - (A) The firm should have minimum 7 years experience in Bridge/ Flyover Design Consultancy as on date of advertisement.
      - (B) Minimum Length & Minimum Nos. of Bridge for which consultancy have been provided 500 Mtr./ 5Nos.  
(For Joint Venture 3 Nos. for either of the partners)
- Working experience certificate shall be submitted of central / state govt./ Central/ State PSU's bridge project.
3. Experience of Bridge Designer

Two bridge designers must have more than 7 years of professional experience in the field of Bridge design. The Bridge Designers would have worked exclusively with the organization at least 3 years prior to the date of advertisement.
  4. Turnover of the firm

Annual turnover of the firm should be equal to or more than 100 lacs. in any one year in last five years
  5. Duration of Empanelment                      2 years
  6. Consultant must not have litigation with UPSBC Ltd, Lucknow and in this regard the consultant should submit an undertaking in Technical Bid
  7. The consultants shall proposals either in sole capacity or in JV or in Association. Joint Venture/ Association shall not have more than three firms: Any entity which has been barred by the Ministry of Road Transport and Highways (MORTH), U.P.P.W.D, UPSBC Ltd. & other agencies of U.P.Govt. and the bar subsists as on the date of application,

would not be eligible to submit the bid, either individually or as a member of a Joint Venture.

8. The proposals must be properly signed as detailed below:

- 8.1
- i. by the proprietor in case of a proprietary firm
  - ii. by the partner holding the power of Attorney in case of a firm in partnership (A certified copy of the Power of Attorney on a stamp paper of Rs. 100 and duly notarized shall accompany the Proposal).
  - iii. by a duly authorized person holding the Power of Attorney in case of a Limited Company or a corporation ( A certified copy of the Power of Attorney on a stamp paper of Rs. 100 and duly notarized shall accompany the Proposal).
  - iv. by the authorized representative in case of Joint Venture.

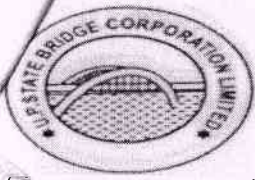
8.2 In case a Joint Venture/ Association of firms, the proposal shall be accompanied by a certified copy of legally binding Memorandum of Understanding (MOU) on a stamp paper of Rs. 100, signed by all firms to the joint venture confirming the following therein:

- i. Date and place of signing
- ii. Purpose of Joint Venture/Association must include the details of contract works for which the joint venture has been invited to bid)
- iii. A clear and definite description of the proposed administrative arrangements for the management and execution of the assignment Name of Lead Firm and other partner of JV should be clearly defined in the MOU
- iv. Delineation of duties/ responsibilities and scope of work to be undertaken by each firm along with resources committed by each partner of the JV/Association for the proposed services
- v. An undertaking that the JV firms are jointly and severally liable to the Employer for the performance of the services
- vi. The authorized representative of the joint venture/Association

The Association firm shall give a Letter of Association, MOU as in (i) to (vi) above except v. letter of Authorization, copies of GPA/SPA for the person signing the Documents and a Certificate of incorporation.

8.3 In case of Joint venture, one of the firms which preferably have relatively higher experience will act as the lead firm representing the Joint Venture. The duties, responsibilities and powers of such lead firm shall be specifically included in the MOU/ agreement. It is expected that the lead partner would be authorized to incur liabilities and to receive instructions and payments for and on behalf of the Joint Venture. Payment to be made to the JV can also be made to the account of the JV. For a JV to be eligible for bidding, the experience of lead partner and other partner should be as indicated in data sheet. In case of J.V, either of the partners should fulfill all eligibility requirements.

9. Designated Consultant has to submit Rs. 1.0 lac as earnest money at the time of submission of proposal in separate envelope to the office of the undersigned. The earnest money will be in the form of NSC/KVP/ Fixed Deposit duly pledged in favour of


