## Office Order

### Sub: Authorization for execution of MoU with the Railway Authority for the construction of railway portion works.

In continuation of the policy and practice followed by Uttar Pradesh State Bridge Corporation Limited (UPSBCL), it is stated that from time to time UPSBCL is entrusted by the Railway Authority with the construction of the main span and allied components of bridge works falling within the railway portion of the ROB, based on requests received from the Railway Authority.

Such works are undertaken by UPSBCL only after execution of a duly approved Memorandum of Understanding (MoU) between the Railway Authority and UPSBCL. It is hereby reiterated that the entire cost of such works in the railway portion, including construction cost, supervision charges, centage charges of UPSBCL, testing charges, and any other incidental or statutory expenditure, shall be borne exclusively by the Railway Authority. No financial burden on this account shall be devolve upon UPSBCL.

To expedite the process of execution of such works and to avoid delays in finalization and signing of the MoU, the concerned **Zonal Chief Project Manager (CPM)/GM of UPSBCL** is hereby authorized to sign the MoU on behalf of UPSBCL, subject to compliance with the approved standard terms and conditions of the Corporation.


The Zonal Chief Project Manager/GM shall ensure that:

1. The work is executed strictly in accordance with the guidelines, specifications, safety norms, and inspection requirements prescribed by the Railway Authority.
2. The scope of work, responsibilities, payment terms, timelines, and other contractual provisions are clearly defined in the MoU.
3. All statutory approvals and compliances required for the execution of railway portion works are duly adhered to.
4. No financial, contractual, technical, legal, or future maintenance liability of any nature shall be accrued in future to UPSBCL, except to the extent specifically and expressly provided in the MoU.

Upon completion of the work, the constructed portion shall be handed over to the Railway Authority as per prescribed procedures, and all responsibilities relating to operation, maintenance, and liabilities arising thereafter shall rest solely with the Railway Authority. This order is issued with the approval of the competent authority.


